RESOLUTION OF THE BOARD OF EDUCATION OF THE IRVINE UNIFIED SCHOOL DISTRICT APPROVING FORMS SAB 50-04 APPLICATIONS SUBMITTED FOR PLANNING AREA 5B ELEMENTARY SCHOOL, CULINARY ARTS CLASSROOM AT NORTHWOOD HIGH SCHOOL, RELOCATABLE CLASSROOMS AT CYPRESS VILLAGE ELEMENTARY SCHOOL, AND RELOCATABLE CLASSROOMS AT JEFFREY TRAIL MIDDLE SCHOOL

WHEREAS, the Irvine Unified School District (the "District") is a school district duly created, established and authorized to exercise its powers under and pursuant to the laws of the State of California, which include the provision of school services; and

WHEREAS, the District has been approved by the State Allocation Board (SAB) for eligibility under the School Facilities Program (SFP) of the Leroy F. Greene Facility Act; and

WHEREAS, the District has identified the need for a new classroom buildings at Planning Area 5B Elementary School, Culinary Arts Classroom at Northwood High School, Relocatable Classrooms at Cypress Village Elementary School, and Relocatable Classrooms at Jeffrey Trail Middle School (Projects) and has caused plans and specifications to be drawn for the Projects; and

WHEREAS, the District has submitted, or will submit to the Office of Public School Construction (OPSC) Form SAB 50-04 (Form 50-04) Applications for Planning Area 5B Elementary School, Culinary Arts Classroom at Northwood High School, Relocatable Classrooms at Cypress Village Elementary School, and Relocatable Classrooms at Jeffrey Trail Middle School; and with all accompanying the Division of the State Architect (DSA) approved plans and specifications and all pertinent documentation pertaining to the Projects; and

WHEREAS, the District has submitted, or will submit to the California Department of Education (CDE) all pertinent documentation pertaining to the Projects; and

WHEREAS, the District currently has eligibility under the SFP in the K-12 grade category to supplement the funding of the Projects; and

WHEREAS, the District has the need for additional space and new classroom buildings for future growth as enrollment continues to climb in order to more efficiently serve students in the District; and

WHEREAS, the District's loading standard is 30-35 students per classroom for grades K-12; and

- **WHEREAS,** the District on Form 50-04 requested K-12 grade new construction grants (Grants) in order to have sufficient funds to build the Projects; and
- **WHEREAS,** the Grants equate to the need for additional teaching stations under the SFP loading standard; and
 - WHEREAS, there are new teaching stations in the Projects; and
- **WHEREAS,** the District states that it can adequately accommodate the students that will be attending the Projects during the next five years with the total classroom facilities in the Projects; and
- WHEREAS, State funds will be used to construct the Projects as designed for the purpose of providing the classrooms identified in the plans to house a minimum number of students; and
- **WHEREAS**, the District acknowledges that the District will satisfy its obligation to house the pupils for which the grants are being received for the Project.
- **NOW THEREFORE,** be it resolved by the Board of Education of the Irvine Unified School District:
- **Section 1.** As the decision making body for the District, the Board of Education, has reviewed and considered the information contained in Form 50-04 pertaining to the Projects, the District's five-year projection, and the current need to construct the Projects.
- **Section 2.** The District acknowledges its responsibility to provide adequate school housing for the students.
- **Section 3.** The District acknowledges that student grants from the Leroy F. Greene School Facility Program will be used for new classrooms needed to adequately house the students at the Projects.
- **Section 4.** The District finds they can adequately house the students that will be attending the Projects as it is currently designed.
- **Section 5.** The District finds that based on the District loading standard of 30-35 students per classroom, the classrooms in the plans will adequately house the number students.
- **Section 6.** The Board of Education hereby approves the SAB 50-04 Form for Applications for Planning Area 5B Elementary School, Culinary Arts Classroom at Northwood High School, Relocatable Classrooms at Cypress Village Elementary School, and Relocatable Classrooms at Jeffrey Trail Middle School for funding as submitted by the District.
