

**SCOTTS VALLEY UNIFIED SCHOOL DISTRICT  
RESOLUTION NO. 18-006  
SUFFICIENCY OF INSTRUCTIONAL MATERIALS**

**WHEREAS**, the Board of Trustees of Scotts Valley Unified School District, in order to comply with the requirements of *Education Code* Section 60119 will hold a public hearing on September 26, 2017 at 6:00 p.m., which is on or before the eighth week of school (between the first day that students attend school and the end of the eighth week from that day) and which did not take place during or immediately following school hours, and;

**WHEREAS**, the Board of Trustees provided at least 10 days notice of the public hearing, posted in at least three public places within the district that stated the time, place, and purpose of the hearing, **and**;

**WHEREAS**, the Board of Trustees encouraged participation by parents, teachers, members of the community, and bargaining unit leaders in the public hearing, and;

**WHEREAS**, information provided at the public hearing and to the Board of Trustees at the public meeting detailed the extent to which sufficient textbooks or instructional materials were provided to all students, including English learners, in the Scotts Valley Unified School District and;

**WHEREAS**, the definition of "sufficient textbooks or instructional materials" means that each student, including English Learners, has a standards-aligned textbook or instructional materials, or both, to use in class and to take home, which may include materials in digital format, and;

**WHEREAS**, between the 2008-09 through the 2017-18 fiscal years, the definition of "sufficient textbooks or instructional materials" also means that all students who are enrolled in the same course within the Scotts Valley Unified School District, have standards-aligned textbooks and instructional materials from the same adoption cycle, and;

**WHEREAS**, sufficient textbooks or instructional materials were provided to each student, including English learners, that **are aligned to the academic content standards and** consistent with the cycles and content of the curriculum frameworks in the following subjects:
