D. BOARD UPDATE/DISCUSSION

Trustee Rains attended the Homecoming Game on 10/6. She met as part of the Parcel Tax Subcommittee where they discussed the contracts for the Polling firm.

Trustee Warner spent time with his kids' sports, and they were able to get their pumpkins as well.

Trustee Snyder participated with Trustee Rains in the Parcel Tax Sub-committee meeting. He also participated in the first session of Inside Education being put on by the County Office of Education where the focus was on Pre-K education. He attended the SVEF meeting where they honored Michele Gray for her contribution to the community.

Trustee Shulman attended Lozano Smith's Back to School Legal Update Workshop at the County Office of Education. He attended the stadium committee fundraising event at Malone's. He will attend a Public Hearing Thursday for the Scotts Valley Planning Commission where they will talk about the Notice of Proposed Development at the Shell gas station on the corner of Scotts Valley Drive and Glenwood Drive. On 11/3 he will attend the Santa Cruz County Civics Summit.

E. SUPERINTENDENT'S REPORT

Highlights since last meeting:

* Attended the SVEF meeting with Michelle Stewart. This meeting was connected to the Modern Woodsmen Volunteer of the Year awards. Mr. Erik Wyner - Cross Country Coach, Math Teacher, and Haunted House Leader - received an award for the Haunted House extraordinaire. Michele Gray received an award for her volunteerism for SVEF. The District extended congratulations to these amazing individuals.

* Along with several members of the district office, attended the free Lozano Smith Back to School Workshop on 9/28.

* Also on 9/28 several teachers and administrators attended the History Social Science Framework rollout.

* Our District Threat Assessment Team has been meeting with the Scotts Valley Police Department to review protocols and communications regarding our mutual agreements should certain situations arise.

* Attended the SVHS vs. Carmel football game where Scotts Valley beat Carmel for the first time since 2005. We are now in the same league so this win truly counts.

* Per Assembly Bill 1432 the Superintendent is required to report out on the Mandated Reporter training within the first 6 weeks of school. This training must be completed by all district employees, including EWA employees and volunteers. The District has achieved 100% compliance to this mandate.

* On 10/2 and 10/3 the entire middle school staff participated in a training called Capturing Kids' Hearts, and there will be a presentation on this at the next board meeting.

* Attended the SVHS Homecoming which started with a wonderful rally, then later our football team

played King City. Our win placed SVHS as the only undefeated team in the league. Our own Philip Goodrich was crowned King, and Emily Erikson was crowned Queen.

* The Chamber of Commerce selection committee met on 10/6 to review applications including Educator of the Year and Youth of the Year. Today the members of the Scotts Valley Chamber, along with the Superintendent, surprised Mary Lonhart who was awarded Educator of the Year, and then Philip Goodrich as Youth of the Year. The Chamber's Gala event will be on 1/20/18, where these individuals will be formally awarded and celebrated. Congratulations to our honorees!

F. STUDENT ADVISORY MEMBER'S REPORT

SVHS had a successful homecoming, including the rally, football games and dance. Last week the SVHS staff participated in emergency preparedness training which included a presentation by the SV Police Department. The Haunted House, with the theme of Area 51, is ramping up. Fall play rehearsals are now underway for the play, "It's a Wonderful Life." Student Government hosted a very fun volleyball tournament two weeks ago.

The SVMS staff participated in staff development training called Capturing Kids Hearts on 10/2 and 10/3. About 30 parents attended a presentation about Teen Talk to preview the newly adopted human growth and development curriculum. Next week, with the support of Sophia Sorensen, LED coordinator from the COE, teachers will be reviewing students' work to analyze the use of appropriate strategies for second language learners. The SVMS campus continues to change and they are excited to see cement being poured and walls going up. The new Administration Building is still on track to open after the Thanksgiving holiday. Students and staff continue to adapt to noise, dust and other construction activities every day.
