COMPREHENSIVE PLANS

The <u>Governing</u> Board <u>of Trustees</u> believes that careful planning is essential to effective implementation of district programs and policies. Comprehensive plans shall identify cohesive strategies for school improvement <u>and</u>, provide stability in district operations, <u>and be aligned to ensure consistency among district approaches for student academic growth and achievement</u>.

The Superintendent or designee shall develop comprehensive Comprehensive plans for adopted by the implementation of the district's vision district shall include the local control and goals, on specific policy topics accountability plan (LCAP) and on other areas asplans required by law. As appropriate, comprehensive or determined by the Board to be in the best interest of the district. Such plans may describe, but not be limited to, anticipated short- and long-term needs, measurable outcomes, priorities, activities, available resources, timelines, staff responsibilities, and strategies for internal and external communications regarding the plan.
