Santa Rosa area experienced an extensive fire, destroying homes of both students and district employees. Fire completely destroyed the Hidden Valley Satellite campus. Schools were closed because all levels of district staff were on mandatory evacuation for extended periods. All schools needed to be inspected and thoroughly cleaned, due to ash and other debris, and declared safe for students to return. The Governor of the State of California declare a state of emergency for Sonoma County due to the fires.
