The are two concerns with the existing supply air duct that was connected to the air handlers.

First the existing supply air duct is surrounded by wood framing, which is not within code as wood is not allowed in the air stream. We would suggest creating a transition piece that would fit from the supply air on the air handler to the point of connection with the duct that is existing.

The second issue is that the duct is undersized for the required CFM by our calculations. We would recommend replacing it with a larger duct that can fit the CFM needs. The existing size of the duct for AH-1 is 24x36 and for AH-2 it is 17x22.

ANSWER:

1. Provide transition from unit to (E) SA drops per SMACNA standards.
2. New units match existing units cfm like for like. (E) duct drops shall remain. The air velocity in the duct will be high in just the SA duct drops and is immediately dissipated in branching ducts, losses are minimal.
