- Site Visit: Visit site to confirm existing conditions at the rooms in scope of work. Confirm typical conditions at adjoining spaces to ensure new work matches existing work.
- Documentation: Prepare drawings as required to be able to obtain a bid from a contractor. Drawings to include:
 - Cover Sheet
 - Reflected Ceiling Plan of the 10s Wing
 - Details of typical ceiling perimeter conditions
- Exclusions:
 - Bidding and CA: Bidding and CA phases are excluded. Please advise if you would like a fee for these services.
 - Specifications: Specifications are excluded. Ceiling Manufacturer's recommendations should be sufficient to control quality of the installation.
 - Alternate Systems: My understanding of the project is that matching the existing in-place systems is the desired effect. Therefore, optional systems will not be considered.
 - Mechanical and Electrical Consultants: MPE scope will provide for removing and reinstallation of MPE items as required to make fully

functional. A consultant will not be required if the District concurs with this scope of work.

- o HazMat: Our assumption is that the District will identify any existing hazardous materials.
3. Fee Proposal: Per the attached spread sheet, our fee proposal is Not-To-Exceed \$4,365.
