**RESOLUTION  
CERTIFYING TO THE BOARD OF SUPERVISORS OF LOS ANGELES COUNTY  
ALL PROCEEDINGS IN THE NOVEMBER 6, 2018, GENERAL OBLIGATION BOND  
ELECTIONS (MEASURES "SMS" AND "M")**

**WHEREAS**, on June 14, 2018, the Board of Education (the "Board") of the Santa Monica-Malibu School District (the "District") of the County of Los Angeles (the "County"), State of California (the "State") formed its School Facilities Improvement District No. 1 of the Santa Monica-Malibu Unified School District (Santa Monica Schools) ("SFID No. 1") and its School Facilities Improvement District No. 2 of the Santa Monica-Malibu Unified School District (Malibu Schools) ("SFID No. 2");

**WHEREAS**, on July 19, 2018, the Board adopted its Resolution No. 18-01a (the "Santa Monica Resolution") ordering an election for general obligation bonds (the "Santa Monica Bond Election") to be held within the boundaries of SFID No. 1 on November 6, 2018; and

**WHEREAS**, on July 19, 2018, the Board adopted its Resolution No. 18-02a (the "Malibu Resolution") ordering an election for general obligation bonds (the "Malibu Bond Election") to be held within the boundaries of SFID No. 2 on November 6, 2018; and

**WHEREAS**, the Santa Monica Resolution and the Malibu Resolution were duly delivered to the Registrar of Voters for the County; and

**WHEREAS**, the Santa Monica Resolution and the Malibu Resolution were duly delivered to the Clerk of the Board of Supervisors of the County; and

**WHEREAS**, notices of the Santa Monica Bond Election and the Malibu Bond Election were duly given; and

**WHEREAS**, on November 6, 2018, the Santa Monica Bond Election was duly held and conducted within the territory of SFID No. 1 for the purpose of voting on the proposition of issuing bonds of the District in the amount of \$485 million, known as Measure SMS ("Measure SMS"); and

**WHEREAS**, on November 6, 2018, the Malibu Bond Election was duly held and conducted within the territory of SFID No. 2 for the purpose of voting on the proposition of issuing bonds of the District in the amount of \$195 million, known as Measure M ("Measure M"); and

**WHEREAS**, the Board has received the Canvass and Statement of results of the election from the County Registrar of Voters (the "Certificate of Election Results"); and

**WHEREAS**, it appears from the Certificate of Election Results that more than 55% of the votes cast on Measure SMS and on Measure M were in favor of issuing the aforementioned bonds.

**NOW, THEREFORE, THE BOARD OF EDUCATION OF THE SANTA MONICA-MALIBU UNIFIED SCHOOL DISTRICT DOES HEREBY FIND, DETERMINE AND CERTIFY AS FOLLOWS:**

**Section 1. Entry Upon Minutes.** In accordance with Education Code Section 15274, that entry be made upon the minutes of this meeting that Measure SMS and Measure M have

both been approved by more than 55% of the votes cast at the Santa Monica Bond Election and the Malibu Bond Election.

**Section 2. Certification to County Board.** In accordance with Education Code Section 15274, that it is hereby certified to the Board of Supervisors of Los Angeles County that all proceedings of the District in connection with the Santa Monica Bond Election and the Malibu Bond Election both occurring on November 6, 2018 Bond Election have been accomplished according to law.

**Section 3. Delivery of This Resolution.** That the Secretary of the Board is hereby requested by the Board to deliver a copy of this Resolution to the Los Angeles County Superintendent of Schools, together with a request that, pursuant to Education Code Section 15274, the County Superintendent deliver a copy of this Resolution and the Certificate of Election Results which is attached hereto as Exhibit A to the Los Angeles County Clerk of the Board Supervisors.

**Section 4. Effective Date.** This resolution shall take effect on and after its adoption.
