

### Site Council Minutes

December 3, 2018

I. Meeting called to order at 3:00 pm

II. Officers elected:

- a. President: Sasha Oster
- b. Vice President: Alexis Siniscalco
- c. Secretary: Lory Hovland

III. Action Items

- a. The SPSA for this year, 2018-2019 was reviewed along with the comments/suggestions and line items that have come up since the previous approval as follows:
  - i. Historically, PLC time has not been fully utilized. Look at using some of that funding to pay teachers for after school tutorials especially in math. It was suggested that this could occur a couple of weeks before the end of a quarter. Saturday school is also a possibility and that would not cost the school money.
  - ii. Look at using PLC time for Tech Thursdays, once a month.
  - iii. Add extended day pay for teachers to Title 1
  - iv. Add training/conference budget of \$1500 for each administrator
  - v. Look at utilizing community building funds and parent education funds for a social-emotional learning support. Add language into SPSA.
  - vi. Stipend for TOSA for Lehman elementary was proposed. The council was mixed in approving it as they do not understand why Comstock is responsible. The large size of Lehman's 6<sup>th</sup> grade was presented as well as the concept of supporting a feeder school. Questions about supporting Monroe, Biella, etc were discussed. Principal will bring payroll hand-book to site council once it is complete. In the meantime, we will use general funds. Site council may approve 2<sup>nd</sup> semester stipend to support general fund.
  - vii. Site council would like to see SPSA money used to support additional counseling; it was expressed that one counselor handling all of the counseling responsibilities is a big job. We will pursue this based on funding.

IV. The school safety committee updated the School Safety plan. The site council read and approved the plan today.

- a. Sign updated By-Laws, Parent Involvement Activities sheet: These were reviewed and signed by Principal and Chairperson, Sasha Oster as appropriate.

V.

We will begin discussions with stakeholders to develop the 2019-2020 SPSA as follows: February: parent groups; March: Staff and student surveys. The new SPSA will then be review
