Hey Blaine, Beverly and Robin,

As promised I have attached the cost analysis for your transportation to this email. What my team did is ran a full Monday so we can assume most of the week the routes will look the same. They may change a tiny bit with early outs, but usually the routes stay pretty much the same. By taking the daily cost given in the attached document and running these routes for 180 days it comes out to \$774,900 for the year.

We didn't quote for summer transportation since we don't know how many students go to summer school, but as you can see even if we transported them all, it would be still under that 1 Million price you currently have.

The routes look great, but I always like to caution when sending these through that we always come across the situation where Johnny and Susie can't be in the same vehicle and then we have to add another route here or there. Again it should not make that big of a difference though, I just always like to say it. ©
