My family has a long history of attending Santa Rosa City Schools. In addition to my daughter noted above, my grandfather graduated from Santa Rosa High School and my parents graduated from Herbert Slater Middle School and Montgomery High. Also, my brother, sister, wife, and I graduated from Herbert Slater Middle School and Montgomery High School. Many other relatives have attended and graduated from Santa Rosa City Schools.

My wife, Kori, taught general education for 5 years in Rincon Valley Unified School District. She is currently an adjunct faculty member with SRJC working as a Disability Specialist in the Disability Resources Department and has a private practice specializing in support for students with learning disabilities and ADHD.

My daughter is currently attending SSU and is working towards her masters and teaching credential and wants to become an elementary school teacher.

I have been the estimator and project manager for 13 school projects including the construction of R.L. Stevens Elementary School for the Wright District, one of Santa Rosa City Schools' elementary feeder districts.

I became more engaged as a volunteer for SRCS in 2015 when I began serving on the Bond Oversight Committee for Measure I. I have been chair since 2015. I later joined the committee for Measure L.

The Santa Rosa City Schools have given so much to my family and me that I would like to do more in return.

I believe my knowledge of the district, my experience in construction, my participation on the bond committees, my financial report experience, and my teaching experience would make me an asset to the board. I am a quick study and would hope to get up to speed quickly on the many aspects under the Board's purview.
