

EXHIBIT "A"
LEGAL DESCRIPTION

Lying within the City of Santa Rosa, County of Sonoma, State of California and being a portion of the Lands of City of Santa Rosa High School District, as described by Deed recorded in Book 2120 at Page 506, Official Records of Sonoma County, said portion being more particularly described as follows:

Parcel 1 – Fee Acquisition

BEGINNING at a point on the common line between said Lands of City of Santa Rosa High School District and the Lands of Catherine M. Veenis, Trustee of the Catherine M. Veenis Revocable Trust as described by Grant Deed recorded under Document Number 2010-015259, Official Records of Sonoma County, distant 45.00 feet from centerline station 39+37.86 measured at right angles, as said centerline is shown on the "Record of Survey of the Centerline of Fulton Road between Guerneville Road and Piner Road" filed in Book 791 of Maps at Pages 28-30, Sonoma County Records; thence leaving said common line, North 00°10'00" East 303.38 feet; thence North 09°37'50" East 60.82 feet; thence North 00°10'00" East 101.28 feet; thence North 09°17'40" West 60.84 feet; thence North 00°10'00" East 775.96 feet to the common line of said Lands of City of Santa Rosa High School District and Parcel "A" as shown on the map titled "Quail Hollow Unit 3" filed in Book 390 of Maps at Pages 16 and 17, Sonoma County Records; thence along said common line and the westerly extension thereof, South 89°43'33" West 45.00 feet to the northwest corner of said Lands of City of Santa Rosa High School District, said corner also being a point on the centerline of said Fulton Road; thence along said centerline, South 00°10'00" West 1300.09 feet to the southwest corner of said Lands of City of Santa Rosa High School District; thence leaving said centerline of Fulton Road, South 89°36'01" East 45.00 feet to the POINT OF BEGINNING.

Said portion containing 1.38 acres, more or less.

Parcel 2 – Perpetual Easement

Being a perpetual easement with a right of immediate entry and continued possession for the construction, improvement, maintenance, repair and replacement for public roadway purposes including, but not limited to, sidewalk, electricity, gas, sewer facilities, water facilities, public storm drains, telephone, telecommunications, cable television and for such other public or public utility purposes as the City of Santa Rosa may choose to make (whether said utilities are constructed, owned and operated by grantee or by other entities acting under a franchise or license issued by grantee), in, under, along, over and upon that certain real property situated in the County of Sonoma, State of California, described in the legal description below.

Together with the right to landscape said easement, to construct related facilities including the installation of irrigation lines and to perform related functions including the connection of newly installed lines to grantor's existing irrigation lines or water sources where appropriate. Any additional or future landscaping changes proposed by grantor shall be coordinated with and approved in writing by grantee's Department of Recreation and Parks: such approval shall not be unreasonably withheld.

Veenis Revocable Trust as described by Grant Deed recorded under Document Number 2010-015259, Official Records of Sonoma County, distant 45.00 feet from centerline station 39+37.86 measured at right angles, as said centerline is shown on the "Record of Survey of the Centerline of Fulton Road between Guerneville Road and Piner Road" filed in Book 791 of Maps at Pages 28-30, Sonoma County Records; thence leaving said common line, North 00°10'00" East 303.38 feet; thence North 09°37'50" East 60.82 feet; thence North 00°10'00" East 101.28 feet; thence North 09°17'40" West 60.84 feet; thence North 00°10'00" East 775.96 feet to the common line of said Lands of City of Santa Rosa High School District and Parcel "A" as shown on the map titled "Quail Hollow Unit 3" filed in Book 390 of Maps at Pages 16 and 17, Sonoma County Records; thence along said common line, North 89°43'33" East 13.00; thence leaving said common line, South 00°10'00" West 550.75 feet; thence along a curve to the left having a radius of 14.00 feet, through a central angle of 90°00'00", for an arc distance of 21.99 feet; thence South 00°10'00" West 91.00 feet; thence along a non-tangent curve concave to the southeast, from which the radius point bears South 00°10'00" West, having a radius of 14.00 feet, through a central angle of 90°00'00", for an arc distance of 21.99 feet; thence South 00°10'00" West 105.28 feet; thence South 09°17'39" East 60.84 feet; thence South 00°10'00" West 103.36 feet; thence South 09°37'50" West 60.82 feet; thence South 00°10'00" West 302.39 feet to said common line between the Lands of City of Santa Rosa High School District and the Lands of Veenis; thence along said common line, North 89°36'01" West 13.00 feet to the POINT OF BEGINNING.

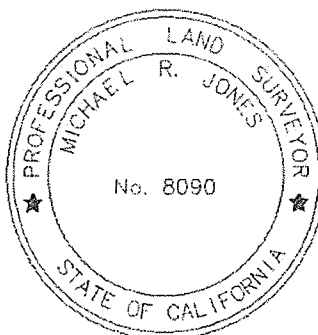

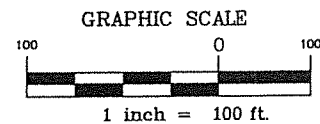

GRANTS TO

THE CITY OF SANTA ROSA, A MUNICIPAL CORPORATION:

A Temporary Construction Easement ("TCE") commencing on January 1, 2021 and terminating on December 31, 2022, with a right of entry in, under, along and across that certain real property situated in the City of Santa Rosa, County of Sonoma, State of California more particularly described in Exhibit "A-1" & "B-1" attached hereto and incorporated herein by reference (the "Temporary Construction Easement Area") for all purposes, as necessary, to include, but not limited, to grading as necessary for the installation of the improvements along the frontage of Fulton Road including construction materials and equipment including trucks and tractors in connection with the Fulton Road Widening Improvement Project (City of Santa Rosa Project Number A010145-2016-14).

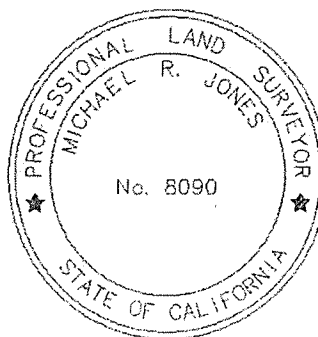

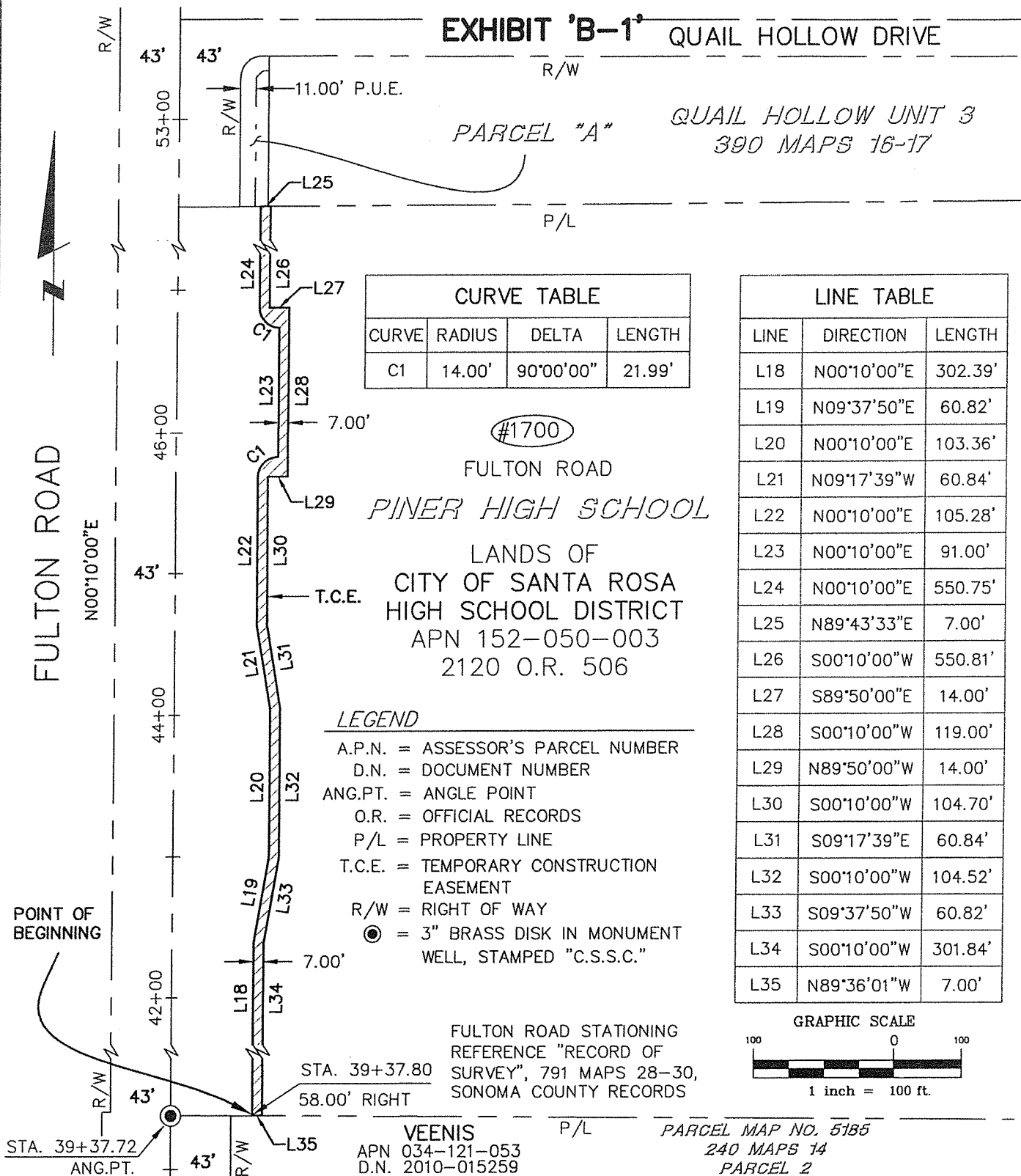
