

## FIRST AMENDMENT TO ATTORNEY-CLIENT AGREEMENT FOR LEGAL SERVICES

THIS FIRST AMENDMENT TO ATTORNEY-CLIENT AGREEMENT FOR LEGAL SERVICES ("Amendment") is effective as of July 1, 2019 (the "Effective Date") by and between the San Mateo Union High School District ("Client"), and the law firm of Stradling Yocca Carlson & Rauth ("Attorney").

### RECITALS

WHEREAS, Attorney and Client entered into that certain Attorney-Client Agreement for Legal Services dated July 18, 2012 for legal services ("Agreement for Legal Services"); and

WHEREAS, the hourly rate for legal services provided by Attorney to Client under the Agreement for Legal Services has not been previously adjusted, and Attorney and Client desire to amend the Agreement for Legal Services to adjust the hourly rate for legal services as provided in this Amendment.

### AGREEMENT

NOW, THEREFORE, for and in consideration of the promises, covenants and conditions set forth herein, Attorney and Client mutually agree as follows:

1. Defined Terms. All capitalized terms used in this Amendment and not defined herein shall have the meanings set forth in the Agreement for Legal Services.

2. Legal Fees. Client agrees to pay Attorney for services rendered on Client's matters based on the attached hourly rate schedule.

3. Effect of Amendment. Except as amended hereby, the Agreement for Legal Services remains unmodified and in full force and effect.

4. Counterparts. This Amendment may be executed in any number of counterparts and each counterpart shall for all purposes be deemed to be an original, and all such counterparts shall together constitute but one and the same Agreement.
