Purposes of Summer School

- Credit Recovery
- Mitigation of “Summer Learning Loss”
- Support for at-risk Students (remediation and intervention)
- Provide limited access to acceleration in some subject areas (also creates more opportunities for students to take courses of interest)
- Credit catch-up/acceleration for newcomer EL students



What was new this summer?

- Self-paced/Mastery approach in Credit Recovery courses
- One course with CSM - Online Business course
- Extended Days and session for students who did not complete course in initial session




Credit Recovery Summer School Student Demographics - 2018-19 School Year


2018-19 School Year Enrollment



School Year Enrollment vs. Mainstream Summer School Enrollment 2018-19 Economically Disadvantaged


2018-19 School Year Enrollment




2018-19 Summer School Economically Disadvantaged vs. Mainstream Credit Recovery SS2019 Cohort = 1168










All but 5 students taking Accelerated Geometry during Summer School 2019 passed the class and earned 10 A-G (UC/CSU eligible) Math credits.




Next Summer
