#### Minutes:

Erin Dobyns, Funding coordinator, updated the Board that her full report to the Board about the Expanded Learning Program will come at a later date. Ms Dobyns also informed the Board as to the status of the Tobacco Use Prevention Education, Community-based Child Abuse Prevention, First 5 Alpine contracts, and other contract funding.

Ms Dobyns also presented updates on LPC and enrollment at the AELC. There are currently 18 toddlers and preschoolers (with 1 more enrollee pending) and 6 infants. There are four preschoolers heading to kindergarten. The anticipated AELC enrollment for fall is 15 preschool and toddlers and 8 infants.

Ms Dobyns shared that AELC is in the exploratory process of planning preschool summer programming with a final answer coming soon to parents.

The Mother's day Brunch was held on May 9 and was a very positive and successful event. Upcoming events include the Father's Day BBQ on May 31 (they are looking for a cook) and the End of the Year Celebration on June 4.
