

AGREEMENT

This agreement is between Alpine County Unified School District (herein after called A.C.U.S.D.) and Steve Mandoki known as (Steve & Sons Mobile Repair) for the period of July 1st 2019 thru June 30th 2020. The service provided by Steve & Sons Mobile Repair will be billed at the following rates.

\$60.00 (sixty dollars) per hour based on a guarantee from A.C.U.S.D. of 25 hrs per week minimum-excluding holidays. The hours of this agreement will be negotiable to fit the schedule of A.C.U.S.D. and Steve & Sons Mobile Repair. No overtime will be billed by Steve & Sons Mobile Repair. Emergency call-out rates will be billed at \$70.00 (seventy dollars) per hour with a two hour minimum. These services will be available 24 hrs per day, 7 days a week. Welding services available at a rate of \$70.00 (seventy dollars) per hour and include service truck, welder and equipment.

Steve & Sons Mobile Repair will turn detailed work orders with hours by the end of the work week and will be paid by A.C.U.S.D. by the following week at the convenience of the A.C.U.S.D. office.

Steve & Sons Mobile Repair assumes responsibility of the school districts tools while in use by Steve & Sons Mobile Repair (Steve Mandoki). Steve & Sons Mobile Repair will also keep current records on maintenance and repairs of Buses for C.H.P. inspection.

A.C.U.S.D. has the right and approval of Steve & Sons Mobile Repair to terminate this agreement at any time upon a 24 hr notice.


