


Q1 Would you be interested in living in housing offered at below market prices that are reserved for Santa Rosa City Schools District employees?



Q2 What is your current household monthly rent/mortgage (excluding utilities, etc.)?



Q3 What percentage of your total household income do you devote to rent/mortgage (excluding utilities)?



Q4 How many people, including yourself, make up your household?



Q5 How many bedrooms do you prefer?







Q9 Would you be interested in living downtown Santa Rosa?



Q10 Would you be willing to live in close proximity to other District employees?



Q11 What amenities would be useful for you to access in a mixed-use development? (Please check all that apply)



Q12 What kind of housing assistance would be most useful for you?



Q13 Are you interested in childcare services?



Q14 What are the ages and number of children that would need childcare?


