Dear Parents and Tribal Officials,

Attached you will find a copy of the 2020 Impact Aid Application that was submitted to the federal government in January 2019 by the school district.

Impact Aid is money paid by the federal government to school districts to make up for lost property taxes to schools when the government has taken land to use for Native American lands, military bases, or other use. The Impact Aid program has been in place since 1950 when President Truman recognized that the federal government owned lands which were not taxable by local governments, leaving school districts at a financial disadvantage. Impact Aid, therefore, replaces lost property taxes.

Currently, our school district uses the Impact Aid funds for staffing at Diamond Valley Elementary School. The grant funds the Principal salary and we are happy to report that as of September 30, 2019 it also funds the Community / Native Liaison position.

A public hearing is held each year during the October board meeting for the community to provide input to the school board regarding Native American students' participation in District programs. The participation data is on page two of this letter.

A second public hearing to comply with revised federal regulations will be held during the regularly scheduled meeting of the Alpine County Unified School District Board of Trustees on December 10, 2019. The meeting will be held at the Administrative Annex located on the District site.

It is our intent to provide Tribal officials and parents/guardians of Native American children the opportunity to comment on the participation and achievement of Native American children on an equal basis in all programs and activities offered by the Alpine County Unified School District. We welcome and appreciate your comments so we can ensure to provide an equal and quality education for all students.
