CONDITIONS

CONTRACT CONDITIONS: All function agreements are made upon and subject to the rules and regulations of the Restaurant and the following conditions:

CONFIRMATION OF RESERVATION: All group bookings require a signed contract and completed credit card authorization form. Otherwise, group space is subject to release without further notice.

PAYMENT: Final Payment is due at the conclusion of the event. We accept Cash, pre-approved Company Check, MasterCard, Visa, Discover Card, Diners Club, and American Express. One bill for all charges will be given to Account (the "Client"), unless prior arrangements are made with the Sales Department.

CHECK PAYMENTS: Make checks payable to . Please include the BEO number on your check. All checks must be sent to the National Sales Office located at 4700 Millenia Boulevard, Suite 400, Orlando, FL 32839. Send checks to attention Sales & Marketing.

SERVICE CHARGE: The Service Charge will be added to the total food and beverage charge. Included in the service charge is the gratuity the client selects below, which shall be distributed to servers, bussers and bartenders and the remainder of the service charge (Administrative Charge) shall be distributed to local, regional and national sales personnel. (Client selected gratuity ____ 18% or ____ (enter %)).

GUEST COUNT GUARANTEES: Final guest count must be guaranteed two (2) business days prior to the event. Saturday, Sunday, and Monday event guarantees are due by Thursday at 4:00 PM. If guarantee is not given, final bill will be based on count at time of booking or number of guests in attendance, whichever is larger.

RESERVATION GRACE PERIOD: We provide a 15-minute grace period for sit-down functions. If group arrives after this time, they will be seated if and when space becomes available. We are unable to seat incomplete parties.

TAX EXEMPT GROUPS: Tax Exempt Groups must provide copy of valid State Sales Tax Exempt Certificate prior to event. Client must be named as exempt organization.

CANCELLATION POLICY: Cancellation must be received at least two (2) business days prior to the event. In the event of a no-show, or cancellation within two (2) business days, the credit card on file will be charged 50% of the contracted amount.

FUNCTION ROOM ASSIGNMENTS: Functions Rooms and Areas are assigned by the Restaurant based upon the final guest count guaranteed. Every attempt will be made to honor The Client's seating requests.

FOOD & BEVERAGE: Due to shared food preparation and cooking areas, it is possible for various food items to inadvertently come into contact with a food allergen from another food item or food preparation materials including, but not limited to, food containing gluten, nuts, etc. While Restaurant takes great care to try and prevent the presence of allergens in menu items, Restaurant is not able to guarantee menu items have not come into contact with potential allergens.

DAMAGES: The Client is responsible for damages to or on the restaurant property or injury to restaurant staff and guests caused by The Client and/or the Client's guests.

CONTRACTUAL LIABILITY: Performance of this Event Agreement is contingent upon the availability of the Restaurant management to complete the same, and is subject to labor troubles, disputes, or strikes, accidents, government (federal, state or municipal) requisitions upon travel, transportation of foods, beverages or suppliers, inclement weather, "Acts of God" and other causes whether enumerated herein or not, beyond the

control of management preventing or interfering with performance. In no event shall the Restaurant, its parent, subsidiaries, affiliated and related entities and its and their respective directors, officers, employees and / or agents be liable for the loss of profit or for other similar or dissimilar collateral, consequential or incidental damages whether based on breach of contract, warranty or otherwise.
