Background Information:

On June 12, 2019, the Board approved the Re-Roofing and Repairs Contract DM014_06.12.19 with Adele Construction, Inc., in the amount of \$872,000.00 for nine (9) sites.

Current Considerations:

There was a decrease in the scope of work at Peninsula High School valued at \$50,000. A Work Directive Change dated September 11, 2019 added work at Dapplegray Elementary, Lunada Bay Elementary, Miraleste Intermediate, Palos Verdes High, Peninsula High, Rancho Del Mar High, Ridgecrest Intermediate, and the Malaga Cove District Offices in the amount of \$50,000.

District staff has confirmed that Adele Construction, Inc. has met all of the requirements for completion of its contract and has completed the work under contract DM014_06.12.19 in the sum of \$872,000.00.
