 - II. CONTEXT FOR WORK

Milpitas Unified School District has requested additional features and accessible path of travel for both pedestrian and service vehicle use. The description of services, identified below, has been discussed in person previously.

III. DESCRIPTION OF SERVICES

Scope of Services:

• Add discuss ring with a net or fence. (inside of D area of the running track)

- Add shot put area (inside of D area of the running track)
- Add softball field
- Add accessible path of travel from the existing gym for both pedestrian and service vehicle
- Add all details related to this work
- Coordination with client and civil engineer as needed

IV. BASIS OF COMPENSATION

BASE will perform the services outlined above as part of this Agreement. Services are invoiced monthly on a percentage complete basis, and billed to the designated fee breakdown below.
