Minutes:

1. Status of Measure T Bond Measure: The measure requires 55% yes votes to pass, and is currently at 54.55%. The canvassing of ballots continues.
2. Status of in-person Instruction: Currently the district has TK-12 selected small groups, as well as in-person cohorts in grade TK-3. Tasks forces are meeting to plan for broader opening at the elementary and eventually the secondary levels.
3. Tiers: Dr. Davis reviewed the parameters of school opening in Purple and Red Tiers.
4. Budget: Dr. Davis discussed the current trend in state revenues, the potential effects of another round of federal stimulus as well as the outlook for the 2021-22 state budget.


