11. SUPERINTENDENT'S REPORT

Minutes:

Dr. Amerson reported that the reopening plans with procedures and protocols had been shared with the board; and he has found the enthusiasm shared by the principals uplifting. This transition period to reintroduce our students and staff back for on-campus learning is journey not a sprint, but he looks forward to the transition process. Back in March of 2020, we had to make the decision to close our schools, and it has been a long year. During this time there has been a lot of work, dedication, and commitment by our entire district to be able to endure this pandemic, but this team has done a great job in prioritizing the safety and security of our staff and students. Once the direction was to begin to transition back to campus, we prioritized providing vaccinations to our community. Throughout this time, Mr. Bauler and Mr. Geno have been leading the efforts of securing the proper PPE and necessary materials. He was happy to report that both of our high schools did extremely well in their most recent WASC reviews; all involved should be applauded. Duarte High School had their WASC review this week, and Mt. Olive had theirs several months ago. WASC is important because it validates the education our students go through. A WASC team not only comprehensively reviews the teaching and learning components, but also the school culture. He provided an update on Measure S and shared that in the coming months we will start bringing more reports and information to the board as we begin the initial first stage process. This will include a lot of engagement opportunities; we want the modernization and upgrading of our schools to be something everyone can celebrate. He shared an update on the directive given in December by our board president related to school consolidation and facility needs. The board has been briefed by our legal counsel on the process and next steps, and it has become clear to us that we want to take a pause to ensure we have a comprehensive process. As a result of that, the board is going to be considering this ongoing conversation into the 2021-22 school year before any final decisions are made. He thanked the Board, Student Board representatives, and his team for their commitment to our school district and the work we are doing.

He commended Leslie Bartlett and the Duarte High team for letting some outside visitors come in and see what a great place it is. He expressed his gratitude to all the teachers and administrators for the many ways they have pivoted to provide instruction during this pandemic; it is impressive. His youngest child started back at school; he had been counting down the days when he would get to see his teacher. His other children are also excited to go back. This year, more than ever, the staff is so deserving of recognition, and he hopes we can recognize them for Day of the Teacher and Week of the Classified.

Mrs. Ku shared that it was great to see everyone's faces in the meeting. She asked everyone to take a moment to recognize this is where we are at: getting back to school, people are getting vaccinated, and things are opening up. Throughout all this COVID-19 journey we have all been learning, and the Duarte school community has done an amazing job rolling with the punches. Many parents do not know what WASC is, and long ago she did not know either, but she learned that WASC is very important and validates that we are preparing our students well so that when they do what they need to do in school, they can attend any university of their choice.

Dr. Amerson emphasized the importance of WASC; it is very high stakes. Upon meeting with the teachers for a debrief, they realized how important it was. They have put in so much work to ensure the school was in a good place to receive the WASC committee and to showcase the wonderful progress that has been made over last few years. He is very proud of the leadership of Mr. Haro, Mr. Earnest, and Leslie Bartlett, and everyone else at DHS-kudos to everyone that played a role. So that everyone could fully appreciate the importance of the WASC validation, he explained exactly what WASC is: Western Association of Schools and colleges. It is an accreditation body that creates standards and expectations that govern whether a school meets the criteria to be designated that their high school diplomas, and the program by which it was created, warrants acceptance by colleges and universities.
