RESOLUTION NO. 17-16-17

**RESOLUTION TO REDUCE OR ELIMINATE PARTICULAR KINDS
OF CERTIFICATED SERVICES FOR THE 2017-2018 SCHOOL YEAR
AND TO ISSUE FINAL LAYOFF NOTICES TO AFFECTED EMPLOYEES**

WHEREAS, the Governing Board of the La Cañada Unified School District ("District") adopted two Resolutions on March 14, 2017 authorizing and directing the Superintendent, or Superintendent's designee, to initiate and pursue procedures necessary to reduce or discontinue the equivalent of 1.2 full-time certificated employees of this District pursuant to Education Code sections 44949 and 44955 because of a reduction of particular kinds of services;

WHEREAS, on or before March 15, 2017, the District properly served on the employees listed on Exhibit "A" notice that the District will reduce or discontinue their services for the 2017-2018 school year;

WHEREAS, Robin Serr did not request a hearing pursuant to Education Code section 44949(b), Education Code section 44949(c)(1), and Government Code section 11505;

WHEREAS, the District has determined that the reduction in services of the English teacher and the French/Spanish teacher at La Cañada High School are no longer necessary due to increases in student enrollment in these classes;

THEREFORE, BE IT RESOLVED by the Governing Board of the La Cañada Unified School District as follows:

1. That the Superintendent or Superintendent's designee is authorized and directed to notify Robin Serr prior to May 15, 2017 and consistent with Education Code section 44949, that the teacher's services will be reduced or discontinued by 0.2 FTE by the District for the ensuing 2017-2018 school year.

2. That the Superintendent or Superintendent's designee is authorized and directed to notify Melissa Stanley that her services as an English teacher will be retained in the 2017-2018 school year at the same level as the 2016-2017 school year.

3. That the Superintendent or Superintendent's designee is authorized and directed to notify Erin Kanner that her services as a French/Spanish teacher will be retained in the 2017-2018 school year at the same level as the 2016-2017 school year.

4. That the Superintendent or Superintendent's designee, is authorized and directed to take any other actions necessary to effectuate the intent of this resolution and to finalize layoffs.

BE IT FURTHER RESOLVED that this action shall be deemed effective immediately.
