What do you feel are the most important issues to be addressed by the task force?

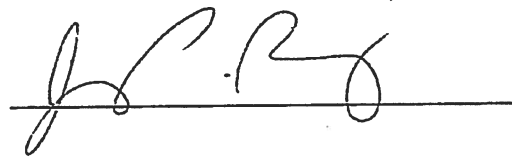

The Task Force should help the Board understand the issues of which students should be assigned to the new school site, but only the Trustees (after taking into account Task Force and public input) should make the determination on which students actually attend school at the new site.

How to balance the needs of very different stakeholders with very different needs, and striking a defensible balance when it's fair to expect that not everyone will be satisfied

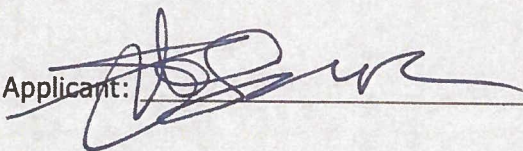
