**RESOLUTION NO. 19-17-18  
RESOLUTION TO ENTER INTO CONTRACT WITH ASPHALT, FABRIC &  
ENGINEERING, INC.**

WHEREAS, the La Cañada Unified School District (“District”) is a public school district organized and existing as a political subdivision of the State of California, and is authorized by the laws of the State of California to award contract pursuant to Alternative Bidding Procedures; and

WHEREAS, the District governing board has by resolution elected to become subject to the uniform construction cost accounting procedures set forth in Article 2 (commencing with Section 22010 of the Public Contract Code) and has notified the Controller of that election; and

WHEREAS, the District has enacted an informal bidding ordinance to govern the selection of contractors to perform public projects pursuant to subdivision (b) of Section 22032 of the Public Contract Code; and

WHEREAS, the District desires to construct Bid #LCF/18-05, Repairs & Alterations to Drainage System at the Football Field at La Canada High School (“Project”) and

WHEREAS, in accordance with Section 22034 of the Public Contract Code, the District solicited informal bids for the Project; and

WHEREAS, District has received bids that are in excess of \$175,000, and has determined that the cost estimate prepared by the District was reasonable;

WHEREAS, the District is authorized to award the contract at one hundred eighty-seven thousand five hundred dollars (\$187,500) or less, to the lowest responsible bidder, if it determines the cost estimate of the District is reasonable; and

WHEREAS, the District has complied with all the requirements of Public Contract Code 22030 et Seq.;

NOW, THEREFORE, BE IT RESOLVED that it is found, determined and resolved by the Governing Board of the District as follows:

1. The above recitals are true and correct.
2. The District has determined that Asphalt, Fabric & Engineering, Inc is a responsible bidder.
3. Based upon all available information, including but not limited to reports, analysis and presentations by District Staff, reviewed by the Board in connection herewith, and pursuant to Public Contract Code section 22034, the Board hereby determines that the bid be accepted and a

contract be awarded to Asphalt, Fabric & Engineering, Inc. for \$185,000 and that it is in the best interests of the District to enter into such contract.
