Insurance coverages and premiums have been negotiated for the next policy year of October 1, 2018 through September 30, 2019.

## Summary

The insurance package totals \$226,243 and reflects an increase of \$14,465 (6.83%) above this year's cost of \$211,778.

The general liability carrier will be Great American Insurance Company. The property and boiler and machinery coverages will be provided by the Travelers Insurance Company. National Union Fire Insurance Company of PA will issue the Faithful Performance (Crime) coverage.

## **Recommendations**

It is recommended the following be approved by the Board of Education:

- (1) Place the general liability and automobile liability with the Great American Insurance Company at a premium of \$150,713 for the policy year October 1, 2018 through September 30, 2019.
- (2) Place the property, including buildings and contents, and contractors' equipment, computer coverages with Travelers Insurance Company at a premium of \$68,341 for the policy year October 1, 2018 through September 30, 2019.
- (3) Place the boiler and machinery coverage with the Travelers Insurance Company at a premium of \$4,192 for the policy year October 1, 2018 through September 30, 2019.
- (4) Place the faithful performance coverage with National Union Fire Insurance Company of PA at a premium of \$2,997 for the policy year October 1, 2018 through September 30, 2019.
