9. REPORTS

9.1. Escalon High School Board Representative Report

Minutes:

Student Board Representative, Hailie Webster reported on events taking place at Escalon High School. Homecoming was a huge success. Students enjoyed dress up days and the football team defeated Ripon. Senior night for volleyball is taking place on Wednesday, October 17th and for football on Friday, October 19th. She reminded the board about Red Ribbon week October 22-26th.

9.2. Quarterly Report on Williams Uniform Complaints

Superintendent Costa reported the district had no Williams Uniform Complaints for the quarter ending October 15, 2018.

9.3. Period 2 Attendance

Minutes:

Superintendent Costa reported the district was at 97.75 up .5%. Two schools were over 98% and six schools were over 97%. Escalon Charter Academy led with 98.91%. Year to date numbers, the district is at 97.85 up .3%. One school was over 99%, two schools were over 98% and six schools were over 97% with ECA leading with 99.07% district wide, we are at 3 year highs for periods one and two.

9.4. EUSD Student Performance on the 2017-2018 CAASPP

Minutes:

Assistant Superintendent Ricardo Chavez reported on the EUSD CAASPP scores for the 2017-2018 school year. His report indicated claims assessed in English Language Arts and Mathematics. Scale scores range from 2000 to 3000, based on the number and difficulty of the items a student answers

correctly. Achievement level 1 = standard not met, level 2 = standard nearly met, level 3 = standard met and level 4 = standard exceeded. ELA CAASPP overall performance comparisons were shown between EUSD, SJCOE and State of California for all grades. Other graphs showed comparisons between all EUSD schools, including the Charter. His report ended with using summative results, such as scores across grades, schools, and student groups. Trends over time, progress toward readiness for college and career, and help validate strengths and prioritize needs.

11. SUPERINTENDENT'S REPORT

Minutes:

Superintendent Costa reported Homecoming and the parade were a huge success. He gave special thanks to Mrs. Vallines, Mr. Furtado and Mr. Simoni. Playing undefeated Ripon, our varsity team rose to the challenge in a 38-7 victory, in addition our JV team was also victorious against Ripon.

Staff members returned from the PLC conference in Salt Lake City. Their excitement was unbelievable and they are looking forward to starting the PLC process. At the leadership meeting, the team had a 90 minute discussion on what needs to be done and where to go from here. It will be a long process, but staff working together can make the changes necessary to ensure that all students will learn.

A Facebook competition has just begun, where teachers can submit photos from their classes, along with a sentence of two caption to post on Facebook. Administrative Assistant to the Superintendent, Emma Barba will be posting them on Facebook and enter their names into a monthly drawing. The districts Facebook followers continues to grow, with over 1000 followers.

He reminded the board about updating the district logo. A logo contest for students, parents, staff and community will begin soon. Submissions that meet the district requirements will be judged. A panel of judges will choose the top 3-5 entries that will then go to the board for their selection. If the process works as designed, we

would be bringing the top entries to the board in early 2019 for their input and/or choice.

Jack Schreder, our facilities consultant, informed the district that the state will be selling \$400 million in Prop 51 bonds on October 17th. The high school project is about \$250 million from the top of the list, so we should be receiving confirmation within a week from the State Allocation Board that we can apply for our funds.

The district will apply immediately and within 4-6 weeks we should receive our state match for the high school modernization. The district has also started the Request for Qualifications process to qualify general contractor(s) and subcontractors for a lease-leaseback for the Dent project.
