

**ADDENDUM TO THE  
CONTRACT FOR EMPLOYMENT OF THE  
SUPERINTENDENT**

This Addendum to the Contract for Employment of the Superintendent by and between the Board of Education ("Board") of the La Canada Unified School District ("District") and Wendy Sinnette ("Superintendent"), amends the Contract for Employment between the Board and Superintendent, dated September 5, 2017, as follows:

1. Section I of the Contract, Term of Contract, is amended in its entirety to state:

This Contract for employment is hereby extended from the effective date of this Addendum through July 31, 2022, unless terminated earlier pursuant to this Contract. It is agreed that Superintendent is required to render twelve (12) months of full and regular service to the La Canada Unified School District during each annual period covered by this Contract, except as otherwise provided herein. Any additional extensions of the term of this Contract shall be subject to approval by the Board.

2. Section II of the Contract, Salary, is amended in its entirety to state:

Superintendent's annual salary during each of the four years covered by this Contract shall be as follows, payable in equal monthly installments pursuant to the District's usual payroll procedures:

2018-2019:    \$260,916

2019-2020:    \$260,916

2020-2021:    \$260,916

2021-2022:    \$260,916

The minimum base annual salary shall be prorated for service of less than a full school year. In addition, the District shall pay Superintendent a one-time off-schedule bonus of six thousand eight hundred twenty-one dollars and thirty-three cents (\$6,821.33). The off-schedule bonus shall be payable in a lump sum, subject to all required withholdings, on or before November 30, 2018.

As provided by Education Code section 35032, the Board may at any time increase Superintendent's salary; any such increase shall not, however, constitute a new employment agreement or extend the termination date of this Contract. Any adjustment in minimum base annual salary made during the term of this Contract shall be in the form of an amendment subject to approval by the Board and shall become a part of this Contract.

3. All other terms and conditions of the Contract for Employment not modified by this Addendum shall remain in full force and effect, up to and including July 31, 2022.
4. This Addendum shall be attached to and incorporated into the original Contract.

The effectiveness of this Addendum shall be contingent upon approval by the District's Board at a regular meeting, as required by law. The provisions of this Addendum are severable and, therefore, if any provision of this Addendum is held invalid, the invalidity shall not affect the other provisions of this Addendum which can be given effect without the invalid provision or application thereof.
