**SUBJECT:** Williams Visitation Update and Reports

### **Recommendation:**

The recommendation is to approve the Williams Visitation Update for submission to the Kern County Superintendent of Schools.

### **Discussion:**

In accordance with Williams Settlement, California Education Code Section 1240 requires County Office of Education personnel to visit selected schools during the first 20 days of instruction. The purpose of the visit is to determine if students have “sufficient” standards-aligned instructional materials in four core subject areas (English language arts, mathematics, history/social science and science), including science laboratory equipment in grades 9-12, and, as appropriate, in foreign languages, and health; and to determine if there are any facility conditions that “pose an emergency or urgent threat to the health or safety of pupils or staff”. Presented before you is the submission of the Williams Settlement 2018-2019 Inspection Results.
