# SPECIAL EDUCATION LEGISLATION



AB 3136 (O'Donnell)

*Special Education Funding – Stalled in Senate Appropriations Committee*

- Requires that special education funding rates to be equalized to the 95<sup>th</sup> percentile after the LCFF is fully funded.
- State legislative intent that the requirements of the act be implemented over the course of 5 years.
- Provides supplemental funding for students with severe disabilities.
