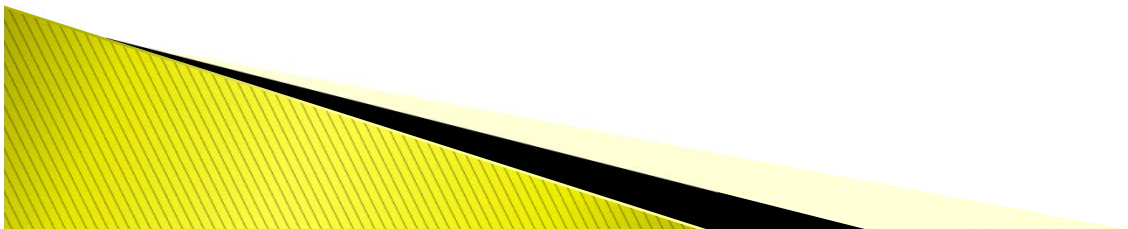

# BOND OVERSIGHT COMMITTEE (BOC)

- BOC formed as required by Proposition 39
  - Provides citizens an opportunity to determine if spending of bond proceeds comply with the stated purpose of the bond measure
  
- BOC MUST HAVE A MINIMUM OF 7 MEMBERS AND  
AND MUST CONTAIN:
  - One member active in a business organization
  - One member active in a senior citizen's organization
  - One member active in a bona fide taxpayers' organization
  - One member who is a parent/guardian with a child enrolled in the school district
  - One member who is a parent/guardian with a child enrolled in the school district, and active in the PTA or school's site council
  - The rest may be community members

# Findings

---

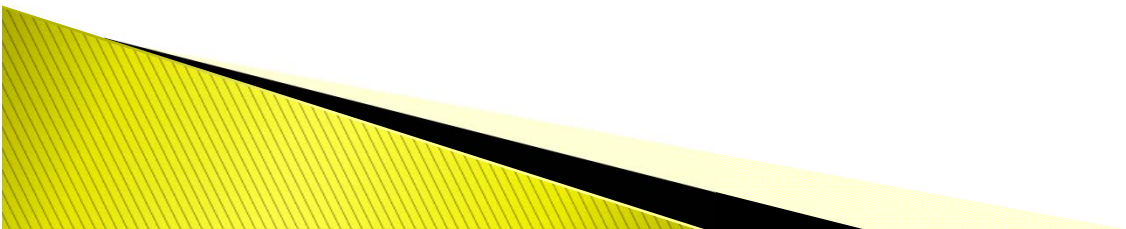
- BOC has reviewed and confirmed all Measure L expenditures are in compliance with the Measure L Bond Language and as approved by voters
- The prioritization of expenditures are congruent with the Facilities Master Plan approved by the Board of Trustees on January 21, 2010; and updated in August, 2013.
- The updated Facilities Assessment and Master Plan was approved by the Board of Trustees on September 5, 2013
- BOC members made One (1) yearly site visit to physically inspect active and completed projects. For 2017, it was on July 27, 2017, and in 2018 it was on August 9, 2018.

# Next Steps

---

- Per Board Resolution No. 05/18–19, the Measure L BOC will be dissolved, and the Measure X BOC will have fiscal oversight over the remainder of Measure L projects. Current Measure L members will be combined with the Measure X members to form a new Measure X Bond Oversight Committee.
