9. REPORTS

9.1. Escalon High School Board Representative Report

Minutes:

Student Board Representative, Hailie Webster was absent, Scott Terpstra reported on events taking place at Escalon High School. The Veterans Day rally was a success. Donations for the Thanksgiving food drive are being accepted through November 14th. Tickets for Sober Grad Bunko are \$25 each and are still available. Sports awards are taking place on November 14th.

9.2. Period 3 Attendance

Minutes:

Superintendent Costa reported on period 3 attendance for the 2018-2019 school year. Attendance is up .15% over prior year and the YTD attendance is up by .24% and has shown an increase for all three periods this year over prior year. In addition, all 3 periods have 97% or higher this year for the district. Van Allen, Dent and Escalon Charter Academy are also up all three periods this year.

10. WRITTEN COMMUNICATION

Superintendent Costa reported Escalon won the playoff game on Friday. This week's game is against Hilmar at Hilmar.

Communication with parents is continuing to improve. An email and text to parents was sent out to inform them of our monthly newsletter and giving them an opportunity to get on the mailing list.

The district and the school sites are involved in the PLC process. Each of our teams are developing their team norms and beginning the process to determine our Guaranteed Standards. The district leadership team determined their norms and just as importantly how they are going to hold teams members accountable for the norms. This is the district's first attempt to make a tool for group members to remember our norms and be able to hold each other accountable.

Superintendent Costa reminded the board the CSBA conference is November 29th - December 1st in San Francisco. Emma will be getting the registration and lodging information to the board members who will be attending as soon as it is available.

On Friday, November 19th, OPSC finished the audit and forwarder the paperwork to their accounting departments to release the funds for the EHS modernization.
