School Facility Conditions and Planned Improvements (Most Recent Year)

Cleaning Process: Somerset Middle School strives to maintain a safe, healthy, nurturing and orderly school campus that encourages positive attitudes in students and staff. The district governing board has adopted cleaning standards for all schools in the district. Schools are on a regular cleaning schedule including wiping surface areas, being swept or vacuumed and the trash emptied. The cafeteria, gym, and all restrooms are cleaned daily. Grounds are groomed on a rotating basis with trash, lawn, and plumbing issues addressed as needed.

Maintenance and Repair: Somerset Middle School is in good repair and the site is being maintained to the standards of the Sylvan Union School District. There was a gas leak discovered at the front of the school in the spring. The leak turned into a couple leaks site wide and had to be detected using indication devices and helium. The leaks were repaired. Somerset is scheduled to have its front office furniture reconfigured and the office setup to be more of a safe environment. The childcare facility, which is housed at Somerset, had sealcoating and striping re-done. The old play structure was removed and we then installed a concrete pad and a cover for the picnic table area. All of the grass and irrigation was removed and was re-done with new irrigation and sod. Two trees were added as well. Somerset Middle School is in good repair and is ready for daily learning activities.

School Safety Plan (School Year 2018-19)

Somerset Middle School has adopted a comprehensive School Safety Plan that is reviewed and updated annually by members of the School Site Council. The Site Council is comprised of teachers, classified staff, parents, and the principal. The Safety Plan for the 2017-2018 school year was formally approved by the school's School Site Council on 2/20/2018. The school staff suggested final changes and had input on new assignments at the 8/9/2017 staff meeting. The revised Safety Plans are presented to the Sylvan Union School District Board of Trustees for annual review and approval. The Safety Plan is reviewed with staff members at the beginning of each school year with particular attention paid to emergency situations and staff and student responses. Safety drills, including fire, earthquake, and lockdown procedures, are held regularly. In addition, the school is inspected annually by the fire marshal and daily by the custodian. All issues discovered during these inspections are given the utmost priority. Copies of the comprehensive School Safety Plan are posted in each classroom and office area.
