AGREEMENT FOR CONTRACTED SERVICES

This Agreement for Contracted Services (Agreement) is effective February 14, 2019 by and between Cypress School District (District) and Autism Diagnostic and Intervention Connections, Inc., Helena Johnson Ph.D (Contractor).

WHEREAS, District is in need of services by a specially trained, experienced, licensed, and competent Contractor, and such services are needed on a limited basis; and

WHEREAS, District is in need of such services, specifically student Independent Psycho-Educational Evaluations to include in-office assessments, one on-site observation of student in educational setting, record review, communication with educators, report, IEP attendance.

WHEREAS, Contractor is specially trained, experienced, licensed, and competent to perform the Contracted Services.

NOW, THEREFORE, the parties hereto agree as follows:

1. Contractor shall perform the Contracted Services as set forth in this Agreement.
2. Contractor shall commence providing services under this Agreement from February 14, 2019 through June 30, 2019.
3. District shall prepare and furnish to Contractor, upon request, such information as is reasonably necessary for the performance of Contractor under the Agreement.
4. District shall pay Contractor pursuant to the attached rate sheet. Payment shall be made within 30 days of receipt of an invoice and approval by the Director of Student Support Services.
5. Contractor, in the performance of this Agreement, shall be and act as an independent contractor. Contractor understands and agrees that he/she and all his employees shall not be considered officers, employees, or agents of the District, and are not entitled to benefits of any kind or nature normally provided employees of the District and/or to which District employees are normally entitled including, but not limited to, State Unemployment Insurance or Workers' Compensation. Contractor assumes full responsibility for the acts and/or omissions of his employees or agents as they relate to the services to be provided under this Agreement. Contractor shall assume full responsibility for payment of all federal, state and local taxes or contributions, including unemployment, Social Security, and income taxes with respect to Contractor's employees.
