RESOLUTION OF THE BOARD OF TRUSTEES OF THE PASO ROBLES JOINT
UNIFIED SCHOOL DISTRICT AUTHORIZING CONTRACTING PURSUANT TO
COOPERATIVE BID AND AWARD DOCUMENTS FROM THE PAJARO
VALLEY UNIFIED SCHOOL DISTRICT

WHEREAS, Cooperative purchasing through contracts allows the districts to save administrative time and expense and satisfies the bid requirements set forth by Public Contract Code Section 20111 and the Pajaro Valley Unified School District has conducted a cooperative bid process which named the Paso Robles Joint Unified School District as a District which may purchase or contract under that bid at the same price and upon the same terms and conditions as the Pajaro Valley Unified School District, and

WHEREAS, on November 28, 2017 sealed bids were timely filed at the Pajaro Valley Unified School District, 205 Blackburn Road, Watsonville, CA 95076, and

WHEREAS, said bids were opened and publicly read aloud at the time and place specified in the Notice to Bidders, and it was determined that the low bidder for the lease of DSA-approved relocatable buildings was McGrath Rent Corps, dba Mobile Modular, who was thereafter awarded the bid on January 19, 2018, and

WHEREAS, the Paso Robles Joint Unified School District wishes to lease or contract for relocatable classrooms, offices, and restrooms for thirty-six (36) months to be located at George Flamson Middle School, and

WHEREAS, this Board has determined it to be in the best interests of the District to contract for the above stated item from the bid awarded by Pajaro Valley Unified School District,

NOW THEREFORE BE IT RESOLVED, ORDERED AND DECLARED that the contract for lease of 24 relocatable classrooms, 2 office units, and 2 restroom facilities to be located at George Flamson Middle School to house students, in an amount not to exceed Twenty One Thousand Three Hundred Forty Nine and no/100 Dollars (\$21,349.00)/per month plus a one time delivery charge of Two Hundred Seventy Six Thousand One Hundred Fifty Five and no/100 Dollars (\$276,155.00) and a one time removal charge of Two Hundred Six Thousand Three Hundred Seventy Eight and no/100 Dollars (\$206,378.00), is hereby authorized and approved and is subject to all terms, conditions and documents as specified in the Pajaro Valley Unified School District's bid and award documents.

BE IT FURTHER RESOLVED, ORDERED AND DECLARED that the Board authorizes the Superintendent, the Chief Business Officer, or designee, is hereby authorized to execute all the necessary contract documents with McGrath Rent Corps, dba Mobile Modular naming the district

as the contracting party and that the Board of Trustees of the Paso Robles Joint Unified School District hereby adopts Resolution No 18-24 on June 28, 2018.
