Those certificated employees with a master's degree shall receive a \$1500 stipend annually.

Those certificated employees with 90 district approved semester college units shall receive a \$750 stipend annually.

Movement on salary schedule shall be consistent with AR 4151.

Verification of completed college units must be submitted with official transcripts and received by the District/County office no later than April 15 of the current school year.

The District/County may approve 15 hours of agreed upon service credit as equaling one college semester unit for the purpose of advancement.

Changes to Schedule reflected below:

- * Board approval 9/12/17: overall schedule adjusted, steps not receiving 4.35% salary increase receive off schedule bonus to reach 4.35% salary increase
- * Overall schedule adjusted: step I class III 3.2% increase from 15-16, 1.859% increase between steps, 3.7% increase between classes; effective 7/1/16 Board approved on 4/12/16
- * 2% salary increase for 2015-2016, effective 7/1/15, Board approved on 6/16/15
- * A minimum of a 4% salary increase for 2014-15, retro to 07/01/14, Board approved 10/14/14, added additional steps.
- * 2% Salary Increase for 2013-2014 with 183 contract days, retro to 07/01/13, Board approved on 10/08/13

- * Per certificated contract negotiations, each full-time teacher will be contracted for 183 (previously 184), with no salary schedule change, Board approved 01/12/10
- * Added "Teacher" per EC 41401 in the document title, Board approved 07/13/10.
- * 3.2% Salary Increase @ Class VI/Step 24 retro to 07/01/07, Board approved 04/08/08.
- * 2% Salary Increase for 2007-2008 with 184 contract days, Board approved on 05/10/07.
- * *6% increase in 19-20 and 3% increase in 20-21. Initial placement out of district years of service credit 7 years highest placement step 8.
