WHEREAS, it is the purpose of this Resolution to accept the recommendation and to order the elimination or reduction of the positions:

One 8-hour per day position, reduced to a 7-hour and 36-minute per day position
[Funded by Teen Parent-Kaiser] (Effective June 30, 2019)

- 4) Project Implementor, Substance Abuse Prevention Education, Student Support & Health Services

One 8-hour per day position, reduced to a 7-hour and 36-minute per day position

The Superintendent or designee shall also notify as appropriate any affected employees that they may be reassigned or transferred; the Superintendent or designee is also authorized to take any other action to carry out the Board's order eliminating the positions designated above.
